The Nominating Committee meeting of the Glynn County Airport Commission (GCAC) met at **8:30 a.m. on Thursday, October 21, 2021 in the Brunswick Golden Isles Airport conference room.**

Agendas, questionnaires, resumes were provided to the Nominating Committee members, staff, and attendees. Commissioner Al McKinnon's term will end in December 2021. The new Airport Commissioner role will begin in January 2022. The term is five years with the opportunity to serve an additional five-year term.

Presentation of the Airport Commissioner Candidates

Edward Farley was introduced and welcomed. He completed his eligibility form. He was interviewed by the nominating committee members.

Eddie Esserman was introduced and welcomed. He completed his eligibility form. He was interviewed by the nominating committee.

Virginia Jackson was introduced and welcomed. She completed her eligibility form and was interviewed by the nominating committee members.

Myrna Scott Amos was introduced and welcomed. She completed her eligibility form and was interviewed by the nominating committee members.

Each candidate was given an opportunity to explain their background, skills, interests, business experience, board experience and their understanding of the roles, functions, and responsibilities of the Airport Commission. Each was asked about their availability to serve, attend regular meetings and committee meetings.

The nominating committee members thanked each candidate and explained that all candidates will be notified when a decision is made. The nominating committee will make a recommendation to the full Airport Commission. The Airport Commission will either approve the recommendation or revise the recommendation. The final candidate will be recommended to the Golden Isles Development Authority for approval.

At the end of the interviews, the Nominating Committee members discussed the backgrounds and qualifications of each candidate. It was agreed that the candidates not selected could be considered for ad hoc committees. All could be considered again for future openings.

The committee members unanimously agreed that their recommendation for the open position is Edward Farley. Eddie Esserman could be considered as an alternate.


